

# RESOLUTION

## **Resolution Rescinding Prior Resolution R-202212-45-279 Designating Angela M. Brancato as a Contract Employee, and Converting Angela M. Brancato to a Temporary County Employee Position for FY23 (45)**

**WHEREAS**, the McHenry County State's Attorney must provide for prosecution in juvenile delinquency cases in the Circuit Court of McHenry County; and

**WHEREAS**, the State's Attorney's Office has found it very difficult to retain an Assistant State's Attorney to prosecute cases in the juvenile delinquency areas and has, over the last two years, had four different Assistant State's Attorneys rotate through that area; and

**WHEREAS**, Angela was an Assistant State's Attorney 2007-2010 in Winnebago County and at the Illinois Department of Juvenile Justice from 2010-2013, and has approximately six years of experience specifically prosecuting juvenile delinquency cases; and

**WHEREAS**, as a retired Assistant State's Attorney, and participating member in the IMRF retirement plan, Angela is prohibited from working more than 1,000 hours in any 12-month period; and

**WHEREAS**, as a retired IMRF member, Angela does not need to contribute to IMRF and does not need the other benefits the county offers, such as vacation time, personal time, and medical insurance; and

**WHEREAS**, the State's Attorney believes that retaining Angela for an approximately six month period will allow a smoother transition to a more permanent Assistant State's Attorney into the juvenile delinquency role and fill a critical gap that the office has at this time.

**WHEREAS**, the State's Attorney previously desired to retain the services of Angela Brancato as an independent contractor and the County Board previously passed a resolution (Resolution R-202212-45-279) authorizing the State's Attorney's Office to enter into an Independent Contractor Agreement with Angela M. Brancato, but after conferring with the County Human Resources Department, and communications from IMRF, it is deemed more prudent to simply bring Angela M. Brancato on in a temporary county position under the same agreement as the Independent Contractor Agreement. Specifically, Angela M. Brancato will be paid \$40.00 per hour and will not receive any county benefits. The amount of her work will be capped at 999 hours for any work done during fiscal year 2023.

**NOW THEREFORE BE IT RESOLVED**, by this County Board of McHenry County, Illinois, rescinds Resolution R-202212-45-279 and the State's Attorney and Human Resources Departments are authorized to hire Angela Brancato as a temporary County employee providing juvenile delinquency prosecution for the State's Attorney's Office during fiscal year 2023; and

**BE IT FURTHER RESOLVED**, that the McHenry County Clerk is hereby authorized to distribute a certified copy of this Resolution to the McHenry County State's Attorney, Human Resources, the Chief Financial Officer, and the County Administrator.
