# Resolution Adopting Amended Bylaws for the McHenry County Senior Services Grant Commission (10)

**WHEREAS**, on September 9, 2006, the McHenry County Board approved Resolution R-200609-23-245 amending the bylaws of the Senior Services Grant Commission; and

**WHEREAS,** on July 19, 2016, through Resolution R-201607-10-181 and again on September 20, 2016, through Resolution R-201609-23-239, the McHenry County Board approved Resolutions further amending the bylaws of the Senior Services Grant Commission; and

**WHEREAS,** Section XII (Amendment) of the Senior Services Grant Commission bylaws enables the bylaws to be amended by a Resolution of the McHenry County Board by simple majority of those voting at regular or special meeting thereof; and

WHEREAS, the Public Health and Community Services Committee convened on January 5, 2023, and is recommending changes to the Bylaws of the Senior Services Grant Commission; and

**WHEREAS,** the County Board desires to further amend the Senior Services Grant Commission bylaws in order to consistently reflect activities of the Commission throughout the bylaws.

**NOW, THEREFORE BE IT RESOLVED,** by this County Board of McHenry County, Illinois, that it hereby amends the Bylaws of the Senior Services Grant Commission, consistent with redline revisions attached, to achieve the following results:

1. Ensure that a Quorum is consistently made at all regular meetings;

2. Revise the Part I. Background and Part II. Purpose Sections to clarify the Commission reports to the Public Health and Community Services Committee;

3. Revise the Part III. Membership Section to:

a. Reduce the overall number of Commission members from 17 to 14 members;

b. Clarify the process of selecting members of the Public Health and Community Services, Transportation, and Finance and Audit Committees that will also participate in the Commission;

c. Clarify the membership of the designee from the McHenry County Council of Governments;

d. Remove the McHenry County Township Highway Commissioners Association representative and replace it with a McHenry County Division of Transportation staff person or designee approved by the Transportation Committee;

d. Clarify the representation of the McHenry County Township Supervisor and McHenry County Housing Authority roles;

e. Clarify the proper Committee and process for selecting non-profit and at-large members;

f. Clarify the methodology of notifying that a member will be absent.

4. Revise the Part IV. Officers Section to define the time and process for selecting the Vice-Chairperson;

5. Revise the Part VI. Quorum Section to reduce the Quorum from 9 members to 7 members; and

6. Revise the Part VII. Voting Requirements and Part VIII. Rules of Order Sections to revise outdated terms; and

**BE IT FURTHER RESOLVED,** that the County Clerk is hereby authorized to distribute a certified copy of this Resolution to the Director of the Planning and Development Department, the Community Development Administrator, and the County Administrator.

SUBJECT: Resolution Adopting Amended Bylaws for the McHenry County Senior Services Grant Commission (10)

#### **Board / Committee Action Requested:**

To approve the adoption of Senior Services Grant Commission bylaws revisions.
