WHEREAS, the Valley Hi Nursing Home operating budget provides for the purchase of fresh, frozen, and boxed food products and food related items to meet the nutritional and dietary needs of residents at Valley Hi as part of the overall food budget; and

WHEREAS, working in concert with the Director of Purchasing, a bid request was developed and sent to multiple potential vendors with four qualifying vendors responding for review and consideration; and;

WHEREAS, the Valley Hi Administrator and the Director of Purchasing have identified Gordon Food Services of Grand Rapids, MI, Martin Brothers Distributing of Cedar Falls, IA, Lakeshore Dairy of Addison, IL and US Food Service of Chicago, IL as vendors offering suitable product and adequate pricing to meet the food and related items requirements of Valley Hi; and

WHEREAS, Gordon Food Services of Grand Rapids, MI, Martin Brothers Distributing of Cedar Falls, IA, Lakeshore Dairy of Addison, IL and US Food Service of Chicago, IL have complied with all criteria set forth to be considered a qualified vendor and has satisfied the requirements set forth by the McHenry County Purchasing Ordinance for submitting an acceptable bid; and

Board / Committee Action Requested:

Valley Hi is seeking authorization to enter into a two-year contract with two option years with Gordon Food Services of Grand Rapids, MI, Martin Brothers Distributing of Cedar Falls, IA, Lakeshore Dairy of Addison, IL and US Food Service of Chicago, IL for the purchase of food and related dietary items.

Background and Discussion:

The Valley Hi Administrator working in concert with the Director of Purchasing issued a bid request to multiple potential vendors for the purchase of fresh, frozen and boxed food with four qualifying vendors responding for review and consideration. After reviewing the submittals, it was determined that Gordon Food Services of Grand Rapids, MI, Martin Brothers Distributing of Cedar Falls, IA, Lakeshore Dairy of Addison, IL and US Food Service of Chicago, IL were responsive, responsible bidders. It is the recommendation of the Purchasing Director and the Valley Hi Administrator that the Food bid be awarded to to all four responsive bidders allowing the Valley Hi dietary staff to shop for the best price, highest quality foods from all vendors, with Gordon Food Service remaining the primary vendor.
