## Resolution Authorizing a Contract with Insight Public Sector SLED to Provide Cymulate Extended Security Posture Management Software Using McHenry County's Allotment of ARP Act 2021 and Emergency Appropriation to FY23 Non-Departmental Budget (20)

**WHEREAS**, the United States Congress took action to provide financial assistance to state and local government across the United States to both mitigate the financial impacts of COVID-19 as well as stimulate economic recovery; and

**WHEREAS**, the County understands that data and infrastructure security is of the utmost concern; and

**WHEREAS**, security threats to the data and infrastructure are ever-evolving on a daily basis; and

**WHEREAS**, the County requires a toolset to evaluate this ever-evolving threat landscape on a consistent basis; and

**WHEREAS**, Cymulate Extended Security Posture Management is the software toolset that enables this ability; and

**WHEREAS**, Cymulate Extended Security Posture Management Software can be purchased through Insight Public Sector SLED via the OMNIA Partners Public Sector Contract #4400006644 cooperative purchasing agreement; and

**WHEREAS**, the purchase will be a three-year term at a total cost not to exceed \$316,088.00 or \$105,362.67 annually; and

**NOW, THEREFORE BE IT RESOLVED**, by this County Board of McHenry County, Illinois, that it hereby authorizes the following emergency appropriation of the following budget line items for the Fiscal Year of 2023 budget.

**Board / Committee Action Requested:**

To approve Resolution Authorizing a Three-Year Contract with Insight Public Sector SLED to Provide Cymulate Extended Security Posture Management Software Using McHenry County's Allotment of ARP Act 2021 and Emergency Appropriation to FY2023 Non-Departmental Budget.

**Background and Discussion:**

Cymulate Extended Security Posture Management Software will strengthen the County's data and infrastructure security posture. Cymulate Extended Security Posture Management Software will enable the County to assess its defensive controls against the latest ever-evolving threats. Since these threats are ever-evolving on a daily basis, we need a toolset that enables us to evaluate our security posture on a consistent basis. Cymulate enables automation of security activities such as threat intelligence testing, red teaming, and security drift prevention. Additionally, Cymulate's endpoint security vector will allow simulation of full attack scenarios of ransomware, and other malware in a controlled and safe manner.

Insight Public Sector SLED is able to provide this three-year contract to provide Cymulate Extended Security Posture Management Software utilizing OMNIA Partners Public Sector Contract #4400006644 at a cost not to exceed \$316,088.00
