WHEREAS, the Planning, Environment and Development Committee has discussed the need to amend the District Boundaries of the McHenry County Stormwater Management Commission.

NOW, THEREFORE BE IT ORDAINED, by this County Board of McHenry County, Illinois, that it hereby authorizes hereby approves and adopts the amended District Boundaries of the McHenry County Stormwater Management Commission; and

ORDINANCE

SUBJECT: Ordinance Amending the District Boundaries of the McHenry County

Stormwater Management Commission (10)

Board / Committee Action Requested:

To approve the amended District Boundaries of the McHenry County Stormwater Management Commission.

Background and Discussion: In 2022, the McHenry County Board (Board) revised the Board district boundaries. At the same time, the McHenry County Stormwater Management Commission (Commission) felt it prudent to amend the district boundaries of the Commission, which mimicked the old Board district boundaries. The revised Commission district boundaries were discussed, reviewed and approved by the Commission at their March 24, 2022 meeting. The number of Commission districts remains at six, but the boundaries now closely follow the County's sub-watershed boundaries rather than political boundaries. The Commission's Bylaws were also amended at the March 24, 2022 meeting to reflect the change in the Commission district boundaries.

On April 19, 2022, the McHenry County Board approved a Resolution adopting the revised Bylaws of the McHenry County Stormwater Management Commission (R-202204-10-087). The McHenry County State's Attorney's Office reviewed the amendments prior to the Resolution approval.

Per the enabling legislation of the Commission in State Statute 55 ILCS 5/5-1062.b, the County Board may approve alternate district boundaries only through an ordinance. This Ordinance shall satisfy the statute requirements for redistricting the Commission from six boundaries that mirrored the old County Board district boundaries to the six new Commission-approved district boundaries as shown on the attached map.
