

# RESOLUTION

## Resolution Supporting the Annual Renewal of maintenance and support for Public Safety Suite Modules with Rave Mobile Safety (29)

**WHEREAS**, the McHenry County Emergency Telephone System Board (ETSB) was created by Ordinance 0-9201-1200-05 to plan, implement, control, maintain, upgrade, and oversee operations of the Enhanced 9-1-1 system to meet current and future demands for the entire County of McHenry; and

**WHEREAS**, on November 21, 2019, the McHenry County Emergency Telephone System Board unanimously voted to enter into contract with Rave Mobile Safety for the Smart 911 application utilized by all public safety telecommunicators in the County to receive subscriber provided information when a 9-1-1 call is placed from a registered mobile device; and

**WHEREAS**, on January 19, 2023, the McHenry County Emergency Telephone System Board voted to enter into a five (5) year agreement for maintenance and support of Rave Smart 911 in an amount not to exceed \$140,599.99 over the five-year agreement period; and

**WHEREAS**, \$28,120 is budgeted in line item 432100-29-2910-801 (Computer Software Support and Maintenance-Contractual) of the FY2023 Budget, and \$28,120 will be budgeted annually in FY2024 through FY2027, and

**WHEREAS**, upon review and discussion, the Law and Government and Finance and Audit Committees support the request and make the recommendation for approval by the McHenry County Board.

**NOW, THEREFORE BE IT RESOLVED**, by this County Board of McHenry County, Illinois, that it hereby supports the McHenry County ETSB in entering into a five-year maintenance and support agreement with Rave Mobile Safety for the Smart 911 application in an amount not to exceed \$140,599.99, with \$28,120.00 paid annually; and

**BE IT FURTHER RESOLVED**, funds for the maintenance and support agreement are accounted for in the ETSB's FY2023 budget line item 432100-29-2910-801 (ETSB - Computer Software and Support); and

**BE IT FURTHER RESOLVED**, that the County Clerk is hereby authorized to distribute a certified copy of this Resolution to the McHenry County ETSB Director; Director of Purchasing; County Auditor; State's Attorney; Chief Financial Officer; and County Administrator.

**SUBJECT:** Resolution Supporting the Annual Renewal of maintenance and support for Public Safety Suite Modules with Rave Mobile Safety (29)

**Board / Committee Action Requested:**

To support the McHenry County Emergency Telephone System Board's renewal of the maintenance and support agreement with Rave Mobile Safety - Smart 911

**Background and Discussion:** November of 2019, the McHenry County Emergency Telephone System Board unanimously voted to enter into contract with Rave Mobile Safety for the Smart 911 application utilized by all public safety telecommunicators in the County to receive subscriber provided information when a 9-1-1 call is placed from a registered mobile device. A subscriber can add as little or as much information they care to share, including but not limited to medical information, vehicle descriptions, pets, known locations, and emergency contacts.

The McHenry County ETSB is now requesting support entering into a five-year maintenance and support agreement with Rave Mobile Safety for the Smart 911 application in an amount not to exceed \$140,599.99, with \$28,120.00 paid annually for five years.
