## **Resolution Authorizing a One-Year Contract with Three Additional Option Years with Multiple Supplemental Staffing Agencies to Provide Supplemental Staffing to Valley Hi Nursing Home (61)**

**WHEREAS**, Valley Hi nursing home provides licensed and certified nursing services to its residents and is staffed at levels determined by the Valley Hi Administrator based on the needs of the residents and above State and Federal requirements; and

**WHEREAS**, due to the current national healthcare worker shortage, Valley Hi has a need for supplemental, contracted staffing to meet facility needs; and

**WHEREAS**, the Valley Hi Administrator worked with the County Purchasing Department to solicit bids from multiple nursing personnel staffing agencies of which all qualified responders were accepted for contract initiation, including Adelphi Medical Staffing of Kennesaw, GA, ATC Healthcare Services of Lake Success, NY, Aya Healthcare of San Diego, CA, Compound Software Group of Plainsboro, NJ, Compu-Vison of North Brunswick, NJ, Delta-T Group Illinois of Oak Brook, IL, Diskriter of Pittsburg, PA, Favorite Healthcare Staffing Services, Global Force USA of Houston TX, Health Advocates Network, dba Staff Today of Boca Raton, FL, Infojini of Columbia, MD, Sunbelt Staffing of Oldsmar, FL, Supplemental Health Care of Cottonwood Heights, UT, Maxim of Chicago, IL, ClipBoard Health of Covina CA, GrapeTree Medical Staffing of Covina, CA and Kare of Houston, TX; and

**WHEREAS**, said contracts will be added to current staffing contracts in place and will be for a term of one-year with three additional option years; and

Valley Hi seeks authorization to enter into a one-year contract with three additional option years with Adelphi Medical Staffing of Kennesaw, GA, ATC Healthcare Services of Lake Success, NY, Aya Healthcare of San Diego, CA, Compound Software Group of Plainsboro, NJ, Compu-Vison of North Brunswick, NJ, Delta-T Group Illinois of Oak Brook, IL, Diskriter of Pittsburg, PA, Favorite Healthcare Staffing Services, Global Force USA of Houston TX, Health Advocates Network, dba Staff Today of Boca Raton, FL, Infojini of Columbia, MD, Sunbelt Staffing of Oldsmar, FL, Supplemental Health Care of Cottonwood Heights, UT, Maxim of Chicago, IL, ClipBoard Health of Covina CA, GrapeTree Medical Staffing of Covina, CA and Kare of Houston, TX.

**Background and Discussion:**

Valley Hi utilizes contracted supplemental staffing to compliment its FT, PT, and registry in-house staff to maintain facility desired staffing levels. Valley Hi routinely staffs above the State and Federal minimum staffing guidelines and is a 5-star rated facility for both overall and RN staffing. To maintain those staffing levels and in response to the national healthcare worker shortage, Valley Hi seeks authorization to contract with supplemental staffing agencies to maintain desired staffing levels.

The Valley Hi Administrator worked with the County Purchasing Department to solicit bids from multiple nursing personnel staffing agencies of which all qualified responders were accepted for contract initiation, including Adelphi Medical Staffing of Kennesaw, GA, ATC Healthcare Services of Lake Success, NY, Aya Healthcare of San Diego, CA, Compound Software Group of Plainsboro, NJ, Compu-Vison of North Brunswick, NJ, Delta-T Group Illinois of Oak Brook, IL, Diskriter of Pittsburg, PA, Favorite Healthcare Staffing Services, Global Force USA of Houston TX, Health Advocates Network, dba Staff Today of Boca Raton, FL, Infojini of Columbia, MD, Sunbelt Staffing of Oldsmar, FL, Supplemental Health Care of Cottonwood Heights, UT, Maxim of Chicago, IL, ClipBoard Health of Covina CA, GrapeTree Medical Staffing of Covina, CA and Kare of Houston, TX.

The Valley HI staffing coordinator will use the established staffing protocols to fill open shifts with the lowest cost, available resource for that shift to control costs.
