

# RESOLUTION

## Approval of a One Year Contract with Mathers Clinic, With an Additional Option Year, to Provide Psychological Assessments Services for the 22nd Judicial Circuit Court and Authorization for an Expenditure Over \$30,000 (42)

**WHEREAS**, the Illinois Compiled Statutes mandates that psychological/psychiatric evaluations be performed prior to the sentencing of certain criminal offenders; and

**WHEREAS**, Mathers Clinic responded to RFP 22-5644 and found to be the lowest responsible bidder to provide psychiatric/psychological assessments to the Circuit Court of the 22<sup>nd</sup> Judicial Circuit of McHenry County; and

**WHEREAS**, expenditures for Mathers Clinic will exceed \$30,000 in Fiscal Year 2023; and

**WHEREAS**, the expenditure for Mathers Clinic was budgeted for in Fiscal Year 2023 Court Administration budget (402250-42-4200-100 Psychological/Psychiatric Services); and

**WHEREAS**, psychological/psychiatric assessments are a necessary expenditure for the administration of the justice by the 22<sup>nd</sup> Judicial Circuit of McHenry County, Illinois; and

**WHEREAS**, the expenditure for this contract will not exceed the budgeted amount in the 4000 budget line of \$695,000 in the Court Administration budget.

**NOW, THEREFORE BE IT RESOLVED**, by this County Board of McHenry County, Illinois a one year contract, effective December 1, 2022, is awarded to Mathers Clinic to provide psychological/psychiatric assessments services as ordered by the 22<sup>nd</sup> Judicial Circuit of McHenry County, with an additional option year for FY 2024; and

**BE IT FURTHER RESOLVED**, that authorization is granted to expended in excess of \$30,000 to Mathers Clinic for psychological/psychiatric assessments services; and

**BE IT FURTHER RESOLVED**, by this County Board of McHenry County, Illinois that said costs shall be paid from the Court Administration FY23 Budget (402250-42-4200-100 Psychological/Psychiatric Services); and

**BE IT FURTHER RESOLVED**, that the County Clerk is hereby authorized to distribute a certified copy of this Resolution to the Chief Circuit Judge, Trial Court Administrator, McHenry County State's Attorney's Office, McHenry County Public Defender's Office, County Auditor, Director of Purchasing, the Chief Financial Officer, and the County Administrator.
