**WHEREAS**, the McHenry County Department of Health (MCDH) has been notified of an additional award of \$1,000 in funding from the Illinois Department of Public Health for the Cities Readiness initiatives (CRI) program; and

**WHEREAS**, the additional funding increases the grant award from \$71,181 to \$72,181 and is not included in the FY2023 budget and requires the approval of the McHenry County Board to appropriate funds; and

**WHEREAS,** designated CRI funding is to be used for the purposes of assessing, prioritizing, building, training, and exercising the necessary resource element and capabilities needed to save lives in the event of an emergency that requires the rapid deployment of emergency medical countermeasures; and

**WHEREAS**, MCDH must be prepared to have identified point-of-distribution (POD) sites of critical medicines and supplies along with sufficient storage and distribution capacity for critical medicines and supplies; and

**WHEREAS**, the additional grant funding was provided to assist MCDH staff to attend an inperson training alongside other regional local health departments to discuss the recent COVID-19 regional response efforts and areas of improvement; and

**WHEREAS**, it is the recommendation of the Board of Health to appropriate an additional \$1,000 to the Department's FY2023 budget.
