

# RESOLUTION - SUPERMAJORITY

## Resolution Authorizing a Fund Transfer from the Coroner's Fund (303) to the General Fund (100) and an Emergency Appropriation to the Coroner's Fund Fiscal Year 2024 Budget. (31)

**WHEREAS,** The County Coroner's Office has strived to set a higher standard within the County Coroner's Office since Dr. Michael Rein took office on December 1, 2020, but also upgraded the physical aspects and being fiscally responsible without using general funds that included morgue equipment, replacing aging vehicles, supplies for scenes, office supplies and improving employee workstations; and

**WHEREAS,** The County Coroner received a over \$113,000 DOJ Grant, while completing the Coroner Office Accreditation, that was used for upgrading equipment, security, and training for the Coroner Office and Deputies, and helping to offset operational cost; and

**WHEREAS,** The County Coroner has been fiscally responsible in using Coroner Funds (303) such as cremation permits, FOIA requests, and other revenue streams; and

**WHEREAS,** The aforementioned items resulted in a increased fund balance in the Coroner's Fund (303); and

**WHEREAS,** The County Coroner's Office recommends transferring Coroner Funds (303) to the General Fund (100) to help decrease the general fund balance and help decrease the property tax burden; and

**NOW, THEREFORE BE IT RESOLVED,** by this County Board of McHenry County, Illinois, that it hereby authorizes and emergency appropriation in the amount of \$50,000 in the following lines:

**Revenue:**

099100-91-31-3100-303 Coroner's Fund-Utilization of Fund Balance \$50,000

**Expense:**

670000-67-31-3100-303 Coroner's Fund -Operating Transfers Out \$50,000

**BE IT FURTHER RESOLVED,** that the County Clerk is hereby authorized to distribute a certified copy of this Resolution to the County Coroner; the Chief Financial Officer; and the County Administrator
