WHEREAS, the anticipated net financial impact of the proposed grade change is under \$100.00 and is expected to be absorbed within the FY24 Budget due to savings from turnover and/or unfilled positions in the Department's roster; and

WHEREAS, the Salary Administration Policy requires reclassification done outside of the budget process be approved by the appropriate committees and the County Board; and

WHEREAS, these proposed changes have been reviewed by the Board of Health, Public Health and Community Services and Administrative Services committees, and are being recommended to the County Board for approval.
