McHenry County Adopt-A-Highway Program

We shared the common goal of making Spring Grove and McHenry County roadways attractive and safe for motorists, which is our main priority and goal. When we are cleaning up our roadways with our partners at Adopt-a-Highway, and our community, we want to make sure we are keeping our volunteers safe. Any activity along the side of the road can pose dangers, and we have included some of our plans for making it as safe as possible.

Proper Attire

- Volunteers will wear safety vests at all times during the cleanup. Vest will be a bright color with reflective panels.
- Volunteers will wear gloves to protect their hands from sharp objects.
- Volunteers will wear closed-toed shoes. Leather shoes or boots with good soles are recommended.
- Wear light-colored clothing and long pants or jeans. Wear a hat and long sleeves to avoid sunburn.

Highway Safety

- When available, use traffic control signs to alert drivers that volunteers are present.
- We will hold our meet/check-in area in the parking lot of the Thompson Spring Grove Funeral Home parking lot where we can interact with our volunteers away from the road.
- We can walk from there to the pickup site to reduce the number of vehicles in the right of way.
- We will not stop or park vehicles on roadways.
- We will stay in the right of way. Only cross the roadway when necessary.
- Groups will keep 5 feet of distance from the pavement edge.
- We will always work facing traffic. We will never turn our backs to oncoming cars.
 If we see an out-of-control vehicle coming our way, it might be possible to avoid
 danger.
- All children will be supervised. The suggested ratio is at least one supervisor for every three children under age 15.
- Never walk on guardrails, and do not lean over bridge railings.
- Do not pick up items on bridges, in tunnels or on overpasses.
- We will watch our footing. Stay off of/away from steep slopes, trenches or any type of drop-off.
- Avoid using headsets, which can prevent us from hearing oncoming traffic.
- We will not enter the roadway or its shoulder areas to pick up trash.

Health Concerns

- We will not pick up anything that could be hazardous to our health. This includes needles, syringes, jagged glass, animal carcasses, urine bottles or heavy objects.
- We will have a first-aid kit on hand at all times.
- We will have a volunteer that is familiar with CPR and general first-aid techniques in case of an emergency.
- We will make sure at least one person in each group has a cell phone and the coordinator's contact information in case of an emergency.
- We will keep a list of any allergies volunteers may have, in case of an emergency.
- We will have sunscreen and insect repellent on hand.
- Avoid overexertion. Drink plenty of water. Drinking water will be available to volunteers at all times.
