SUBJECT: Resolution Authorizing a Workers' Compensation Settlement for Claim #23-3200-

Board / Committee Action Requested:

To approve a resolution authorizing a Worker's Compensation settlement for claim# 23-3200-10.

<u>Background and Discussion:</u> An employee sustained an injury arising out of and in the course of their duties with the County which was deemed compensable under the Illinois Workers' Compensation Act. The employee has received the appropriate medical treatment, reached maximum medical improvement for the injury, and has since returned to full duty. A fair and reasonable settlement in the amount of \$19,461.39, which is reflective of the permanent partial disability, is recommended to close out this claim. If approved by the McHenry County Board, the settlement will be presented to the Illinois Workers Compensation Commission Arbitrator for adjudication.
