Administration Assistant III 6N to Sheriff's Executive Coordinator 9E (32)

Board / Committee Action Requested:

Approval of reclassification of the said position from 6N to 9E.

Background and Discussion: This position was retitled during the recent compensation study but was not able to be reclassed until the Sheriff's Office and Human Resources created a new position description and completed the Archer questionnaire. The Sheriff is currently looking at reorganization opportunities to support current departments, programs and the new training facility. During this process it was determined that the Sheriff and Undersheriff needed a position that could coordinate and support not only their executive offices but their special projects and events. The current position that provided support reported to the Business Manager and had clerical responsibilities that accounted for 50% of the position. This reclassification meets the needs of the executive office and is long overdue.
