Resolution Authorizing the Retitling of Position 51003399 from Public Health Nurse to Clinical Navigation Specialist and Reclassification of Position 51004999 from 2N to 4N within the Department of Health's FY24 Departmental Roster (51)

WHEREAS, two positions within the Department's Public Health Nursing Division were presented to the Director of Human resources for review and re-evaluation, and resulted in the following requested classification changes to the Department's FY24 roster: position 51003399 from Public Health Nurse (11E) to Clinical Navigation Specialist (11E), and position 51004999 from Administrative Specialist I (2N) to Administrative Specialist III (4N); and

WHEREAS, there is no cost for the title change for position 51003399, and the annualized cost of the reclassification of position 51004999 is \$2,505.36 and is expected to be absorbed within the Department's existing FY24 budget; and

WHEREAS, reclassification outside of the budget process requires approval by the appropriate committees and the County Board, and has been reviewed by the Public Health and Community Services and Administrative Services committees, and is recommended to the McHenry County Board.

NOW, THEREFORE IT BE RESOLVED, that the Director of Human Resources is authorized to make the proposed changes to the Department of Health's FY24 Departmental roster, effective July 15, 2024; and

BE IT FURTHER RESOLVED, that the County Clerk is hereby authorized to distribute a certified copy of this Resolution to the Director of Human Resources, the Chief Financial Officer, the County Administrator, and the Public Health Administrator.
