WHEREAS, the McHenry County Facilities Management Department is responsible for maintaining the grounds of the County facilities including mowing, sprinkling, mulching, weeding and cleanup; and

WHEREAS, the Facilities Management Department prepared specifications for the request for proposal (RFP) for lawn/landscaping maintenance at County properties for the Procurement & Special Services Department. The RFP was for a two-year (2) Base Term (FY2025 and FY2026) and two (2) Optional Years (FY2027 and FY2028). The Director of Facilities Management received, reviewed and scored the proposals and wishes to extend a contract to the most responsive/responsible bidder, Langton Group, Woodstock, IL; and

WHEREAS, the costs for lawn maintenance services will be accounted for in the Facilities Management, Division of Transportation, Valley Hi, Workforce Network, and Sheriff's proposed FY2025 budgets; and

WHEREAS, additional lawn and landscape maintenance may be required to maintain the County properties and necessitate the services of Langton Group of Woodstock, IL, and additional funds will be included in the FY2025 budget if such need arises; and

WHEREAS, the Administrative Services and Finance & Audit Committees have reviewed the said request.

NOW, THEREFORE BE IT FURTHER RESOLVED, by this County Board of McHenry County, Illinois that it hereby authorizes the Director of Procurement and Special Services to initiate a two (2) year base contract (December 1, 2024 thru November 30, 2026) with Langton Group of Woodstock, IL for lawn maintenance services in an amount not to exceed: \$130,801 for FY2025 and \$135,234 for FY2026; and

BE IT FURTHER RESOLVED, by this County Board of McHenry County, Illinois that \$130,801 will be accounted for in the development of the FY2025 budget under the following budget line items:
