McHenry County State's Attorney (Dept. 45)

Mission Statement: Representing the People of the State of Illinois, the McHenry County State's Attorney's Office is charged with the duty to prosecute all crimes and represent the County in litigation, act as legal counsel to the County Board, Elected and Appointed Officials and all County Departments.

Department Created By: Illinois State Statute (55 ILCS 5/) Counties Code.

Classification: Judicial

Background: The McHenry County State's Attorney's Office is dedicated to protecting the rights and ensuring the safety of the citizens of McHenry County and supporting the functions of county government. To that end, the State's Attorney's office serves as prosecutor of any person or persons charged with violating the criminal statutes, traffic laws, or conservation laws of the State of Illinois. We support the building of partnerships with law enforcement and the community in an effort to achieve justice, protect crime victims, hold the guilty accountable and deter crime.

Functions: MANDATED BY STATE STATUTE

- **Prosecution:** To commence and prosecute all actions, suits, indictments and prosecutions, civil and criminal, in the circuit court for his/her county, in which the people of the state or county may be concerned.
- Recovery of Debt: To prosecute all forfeited bonds and all actions and proceedings for the recovery of debts, revenues, moneys, fines, penalties and forfeitures accruing to the State or the county, or to any school district or road district in this county.
- County Department Representation: To commence and prosecute all actions and proceedings brought by any county officer in his/her official capacity.
- County Defense: To defend all actions and proceedings brought against the county, or against any county or state officer, in his/her official capacity, within this county
- Victim Witness: Provides guidance and support to victims and victim's families during the prosecution of a crime that was committed.

2024 Highlights

In addition to daily functions, our SAO Civil Division has accomplished several exceptional duties during this fiscal year including:

- The Civil Division formulated a litigation team to focus on the defense of litigation cases in McHenry County. In 2024, the
 Civil Division handled approximately 91 litigation cases. However, in 2024, they are projected to handle approximately 110
 cases
- Since FY17, the SAO's Civil ASA's have litigated and negotiated McHenry County Labor Law matters at no cost to county taxpayers, saving several million dollars in outside counsel fees.
- From January 2024, the Civil Division has handled 66 open litigation files. Twenty-three (23) of those cases have been successfully closed out at **no cost** to the County.

In addition to daily functions, our SAO Criminal Division has accomplished several exceptional outcomes during this fiscal year including:

- Successfully prosecuted two DCFS employees charged with official misconduct and child endangerment. The
 prosecution, spearheaded by McHenry Co. State's Attorney Patrick Kenneally, 1st Assistant Randi Freese and Special
 Prosecution Chief Ashley Romito, resulted in a conviction against Carlos Acosta for his role in the child endangerment
 surrounding the murder of Andrew Freund, Jr.
- Successfully prosecuted several offenders for distributing controlled substances in our community, including those who
 have committed drug-induced homicides. Continued to strengthen our partnerships with the local, state and federal
 agencies investigating drug offenses, which has resulted in a continuing decrease of lethal drugs in our community and
 led to one of the lowest overdose numbers in the state. Evidenced by the convictions we have secured for narcotics
 related offenses, and our pending cases, such as the recent arrests of two Cook County offenders that were in possession
 of 17 kilos of cocaine and fentanyl within McHenry County, and charging eleven additional drug-induced homicides since
 the last reported period.
- Continued to expand the experience and effectiveness of the office by hiring several career and former prosecutors in all divisions, in addition to adding several attorneys committed to the mission and values of the office. Our first-class training program coupled with career prosecutors trying challenging cases with newer assistants has resulted in favorable outcomes for the victims of crimes and the community at large.
- Required cannabis dispensaries in McHenry County to warn customers through in-store signage of the mental health
 dangers associated with cannabis use. Further required dispensaries to eliminate all advertisements claiming that
 cannabis use has medical benefits. McHenry County is the first and only county in Illinois to require cannabis dispensaries
 to add such warnings.

2025 Goals

The Civil Division strives to continue to provide professional, efficient and timely advice to the county elected officials and department heads. We wish to enable the County to run as efficiently as possible, while providing independent, non-partisan legal advice. In furtherance of these goals, we specifically intend to accomplish the following:

- Minimize the total monies paid to outside counsel for labor, employment, worker's compensation, grievance and planning & development matters.
- Continue to work with the McHenry County Division of Transportation regarding the possible acquisition of a new salt dome site.
- Build a stronger bond and relationship with all elected officials and department heads, as well as provide training as
 requested by County HR and County Administration for new and existing elected officials and department heads.

The Criminal Division has several goals heading into 2025. As always, our primary goal is to seek justice for the citizens of McHenry County through aggressive prosecution of the most serious crimes which present safety concerns for the community. Additional goals for the next fiscal year include:

- Maintain a culture of trust and open communication between the residents and businesses of McHenry County and the State's Attorney's Office to increase the public's understanding of the office's duties and activities, improve public safety, and provide a healthy, welcoming county to live in. Core to our mission is obtaining justice for victims and balancing their needs and interests and the severity of the crime against a just outcome for those charged with crimes.
- Continue to thoroughly investigate and prosecute crimes against children. Expand the Crimes Against Children Taskforce
 to additional law enforcement agencies within the county. Focus additional resources on the Human Trafficking
 Taskforce to combat the trafficking of minors and the vulnerable into the sex trade and forced labor.
- Create safer and healthier communities in McHenry County using prosecutorial resources strategically and appropriately, by both aggressively prosecuting the most serious threats to McHenry County while providing effective alternatives to incarceration of non-violent offenders. This outlook has resulted in numerous lengthy prison sentences for the most severe cases, while our office continues to collaborate with all stakeholders towards successful and meaningful rehabilitation of first-time offenders by way of a robust deferred prosecution program.


