**WHEREAS,** THE County Clerk requests that the County Board approve a three (3) year extension to the earlier lease agreement at the rate of \$110,254 per year beginning December 1, 2024 through November 30, 2027.

**NOW, THEREFORE BE IT RESOLVED,** by this County Board of McHenry County, Illinois that the Director of Purchasing is hereby authorized to enter into a there (3) year lease extension with DFM Associates to provide election management software lease and services for the County; and

**BE IT FURTHER RESOLVED,** by this County Board of McHenry County, Illinois that the cost of said agreement has been accounted for and will be expensed from the County Clerk's fiscal budget line item 432100-40-14-1410-100 (Computer Software Support & Maintenance – County Clerk Election – General Fund); and.

**BE IT FURTHER RESOLVED,** that the County Clerk is hereby authorized to distribute a certified copy of this Resolution to the County Auditor; the Director of Procurement and Special Services, the County Treasurer; the Director of Information Technology, Chief Financial Officer, and the County Administrator.
