## Resolution Appropriating Funds for FY2025 Sign Materials (82)

**WHEREAS**, the Division of Transportation annually requires various sign materials necessary to construct and repair traffic control signs along all County Highways; and

**WHEREAS**, bids were received on September 20, 2024, through the Purchasing Department; and

**WHEREAS**, the Transportation Committee of the County Board met on October 30, 2024 and reviewed the bid tabulations for said improvement with the following lowest bid amount for the individual sections of the sign materials bid as follows:

**BE IT FURTHER RESOLVED**, that this project is hereby designated as Section 25-00000-06-GM; and

**BE IT FURTHER RESOLVED**, that the Chairman is hereby authorized to execute the necessary contract documents; and

**BE IT FURTHER RESOLVED**, that the County Clerk is hereby authorized to distribute a certified copy of this Resolution to the County Administrator, the Chief Financial Officer, the Director of Procurement and Special Services, and an electronic copy to the Director of Transportation/County Engineer.

SUBJECT: Resolution Appropriating Funds for FY2025 Sign Materials (82)

---

**Board / Committee Action Requested:**

To approve the resolution accepting bids for sign materials for the FY2025 program and appropriating funds.

**Background and Discussion:** Bids were opened on September 20, 2024, at the Purchasing Department. The annual bid for sign materials is funded through the County Option Motor Fuel Tax Fund.

This is part of the yearly purchase of various sign materials so the Division of Transportation can maintain signs within County Highway right-of-way. The FY2025 budget was established by coordinating previous years' budget amounts and anticipated FY2025 sign material needs with the Maintenance Sign Shop.

The following items were included in this year's request for bids:

- Group 1: U-Channel Posts & Post Pounder Adapter
- Group 2: Aluminum Blanks
- Group 3: Sign Material Roll Goods
- Group 4: Sign Faces
- Group 5: Roll Up Warning Sign Assemblies
- Group 6: Sign Mounting Hardware
- Group 7: Traffic Control Devices
- Group 8: Corrugated Sign Panels

**Impact on Human Resources:** None.

**Impact on Budget (Revenue; Expenses, Fringe Benefits):** \$140,000.00 was budgeted for FY2025 sign materials. The costs to purchase the bid sign materials is \$104,107.68 which will be funded from the FY2025 County Option Motor Fuel Tax Fund.
