SUBJECT: Resolution Appropriating Funds for FY2025 Natural Deicer (82)

## **Board / Committee Action Requested:**

To approve a resolution appropriating funds for FY2025 natural de-icing product.

<u>Background and Discussion</u>: As an annual expense for winter snow and ice control, the necessary materials are salt, calcium chloride and a natural de-icing product. This bid is for 80,000 gallons of the natural de-icing product.

Bids were received by the Procurement and Special Services Department September 16, 2021. Two (2) bids were received. The bid included four option years. This will be the forth year of the contract. The bid was for \$2.15/gallon from SNI Solutions of Geneseo, Illinois.

With the upgraded liquid storage capacity and our increased all liquid snow plow route program the MCDOT has budgeted \$172,000.00 in FY2025. This is then used to manufacture the MCDOT's enhanced brine (blended "Supermix"). Efforts continue to increase the use of liquid product to reduce reliance on rock salt.
