

# RESOLUTION

## Resolution Appropriating funds in FY2025 Authorizing Purchase of four (4) Mower Decks (82)

**WHEREAS**, the McHenry County Division of Transportation (MCDOT) annually budgets for new and replacement equipment; and

**WHEREAS**, four (4) Rino FL10 mowers will be replaced with four (4) John Deere FC10R mower; and

**WHEREAS**, Illinois Association of County Board Members has solicited and secured contract #22-04-00777 and McHenry County is eligible to participate for the following:

Four (4) – John Deere FC10R flex-wing mower decks at a total cost of \$99,058.40 through John Deere AHD, LLC, Harvard, IL; and

**WHEREAS**, the Transportation Committee has reviewed said purchase.

**NOW, THEREFORE BE IT RESOLVED**, by this County Board of McHenry County, Illinois that there is hereby appropriated from the FY2025 budget the sum of ninety-nine thousand fifty-eight dollars and forty cents (\$99,058.40) from the County Option Motor Fuel Tax Fund; Fund-Dept-Div-Main Acct. 262-82-8240-604000 (Machinery and Equipment) for said purchase of the tractor and mower; and

**BE IT FURTHER RESOLVED**, by this County Board of McHenry County, Illinois, that the Chairman of the Board is hereby authorized to execute the necessary documentation to purchase the above items; and

**BE IT FURTHER RESOLVED**, that the Director of Procurement and Special Services is hereby authorized and directed to negotiate the final document to purchase said equipment; and

**BE IT FURTHER RESOLVED**, that the County Clerk is hereby requested to distribute a certified copy of this resolution to the Director of Procurement and Special Services, the County Administrator, the Chief Financial Officer and an electronic copy to the Director of Transportation/County Engineer.

SUBJECT: Resolution Appropriating funds in FY2025 Authorizing Purchase of four (4) Mower Decks (82)

---

**Board / Committee Action Requested:**

To approve a resolution approving the purchase of four (4) right-of-way mower decks for the Division of Transportation (DOT).

**Background and Discussion:** The DOT desires the replacement of four 2001 Rhino FL10 mower decks. These are ten-foot flex wing rotary mower decks. Manufacturer guidelines recommend replacement in 12 years.

The new mower decks will be John Deere FC10R ten-foot flex wing rotary mower decks with torsional suspension and foam filled severe duty agricultural tires.

The mower decks will be utilized by the vegetation section for right of way mowing. Once replaced, the current equipment will be entered into an auction.

Budget Price: \$115,000

FC10R \$24,764.60 each = \$99,058.40

Updated pricing available in November, PO not to exceed budgeted amount.
