Resolution Appropriating Funds in FY2025 Authorizing the Purchase of a Ram 2500 Pickup (82)

WHEREAS, the McHenry County Division of Transportation (MCDOT) annually budgets for equipment; and

WHEREAS, one (1) pickup truck will be replaced and added to the MCDOT equipment capital plan; and

WHEREAS, the Sheriff's Office worked with the Procurement and Special Services Director to issue Bid #23-6516, and received four (4) responses with Sunnyside Company of McHenry, IL being the lowest responsive, responsible bidder; and

WHEREAS, the Division of Transportation (DOT) will utilize Bid #23-6516 for the purchase of one (1) 2024 Dodge Ram 2500 truck for \$48,339.00; and

WHEREAS, Sourcewell has solicited and secured contract #080818-BNL Bonnell Industries for a plow and service body, through the Procurement and Special Services Department; and

WHEREAS, the Transportation Committee met on October 30, 2024 and reviewed the Bonnell Sourcewell contract #06222-BNL for the service body awarded as follows:

WHEREAS, the Transportation Committee has reviewed said purchase.

NOW, THEREFORE BE IT RESOLVED, by this County Board of McHenry County, Illinois that there is hereby appropriated the sum of seventy-seven thousand five hundred ninety-four dollars and fifty-eight cents (\$77,594.58) from the County Option Motor Fuel Tax Fund; Fund-Dept-Div-Main Acct. 262-82-8240-602000 (vehicles) for said purchase of the pickup truck with add-ons; and

BE IT FURTHER RESOLVED, by this County Board of McHenry County, Illinois, that the Chairman of the Board is hereby authorized to execute the necessary documentation to purchase the above items; and

BE IT FURTHER RESOLVED, that the Director of Procurement and Special Services Director is hereby authorized and directed to negotiate the final document to purchase said equipment; and

BE IT FURTHER RESOLVED, that the County Clerk is hereby requested to distribute a certified copy of this resolution to the County Administrator; the Chief Financial Officer; the Procurement and Special Services Director; and an electronic copy to the Director of Transportation/County Engineer.

RESOLUTION

SUBJECT: Resolution Appropriating Funds in FY2025 Authorizing the Purchase of a Ram 2500 Pickup (82)

Board / Committee Action Requested:

For consideration is a resolution approving bids and quotes and appropriating funds for RAM 2500 with Service Body for FY2025.

Background and Discussion: The Division of Transportation (DOT) requests the replacement of a 2013 Ram 2500 pick-up truck with over 190,000 miles on it. The new pick-up truck will be a ¾ ton truck equipped with a steel service body, Western plow mount, back rack, strobes, and a Class IV trailer hitch. This truck will be used every day by the FAST (Fast Action Support Team) to perform maintenance duties and assist in emergency operations and call outs.

Once replaced, the current vehicle will be entered into an auction with an expected selling price of \$8,000.
