WHEREAS, the McHenry County Coroner annually budgets for services such as Autopsies, Toxicology, and Transportation throughout fiscal years; and

WHEREAS, the McHenry County Coroner's Office budgets for these services based on the contracted rates, current needs, and outside factors that may affect demand for these services; and

WHEREAS, the McHenry County Coroner's Office has set higher standards by achieving accreditation through the International Association of Coroner's and Medical Examiners; and

WHEREAS, the current contracts are set to expire on December 1, 2024. Demand and costs for Forensic Pathologists have increased substantially over the past 5 years; and

WHEREAS, the County Coroner and Director of Procurement & Special Services have determined these services are professional in nature and performed only as needed.

NOW, THEREFORE BE IT RESOLVED, by this County Board of McHenry County, Illinois, that it hereby authorizes contracts with Dr. Kristen Escobar-Alvarenga and Dr. Mark Peters for the period of December 1, 2024, to November 30, 2027, with an option year from December 1, 2027 to November 30, 2028. These contracts will cover full autopsies, partial/external autopsies, and case consultations; and

BE IT FURTHER RESOLVED, by this County Board of McHenry County, Illinois that the cost of said agreement has been accounted for and will be expensed from the Coroner's fiscal budget line item 416000-40-31-3100-100 (Autopsies – Coroner – General Fund); and

BE IT FURTHER RESOLVED, that the County Clerk is hereby authorized to distribute a certified copy of this Resolution to the County Coroner, the County Auditor, the Chief Financial Officer and the County Administrator.

2021: 186 autopsies, total cost \$230,550

• 2022: 162 autopsies, total cost \$197,850

2023: 141 autopsies, total cost \$178,650

2024 (to date): 131 autopsies, total cost \$163,750
