

# RESOLUTION

## Resolution Authorizing a Five-Year Devnet Property Tax and wEdge Software License, Maintenance and Support Contract (20)

**WHEREAS**, the County has been successfully utilizing the DevNet Tax software for the past eighteen years; and

**WHEREAS**, the County Assessor, County Clerk, and County Treasurer support the renewal of this agreement for a subsequent five-year term; and

**WHEREAS**, the annual cost of the agreement will be \$127,339.00, paid in quarterly installments on or before December 1, March 1, June 1, and September 1; and

**WHEREAS**, the agreement will be for a five-year term, commencing on December 1, 2024, and terminating on November 30, 2029; and

**WHEREAS**, this agreement is offered by the incumbent tax system provider DevNet, Inc., 2254 Oakland Drive, Sycamore, Illinois 60178; and

**WHEREAS**, the proposed contract having been reviewed and approved by the State's Attorney; and

**WHEREAS**, the DevNet Tax and wEdge Software License, Maintenance and Support Contract has been reviewed and is recommended by the Administrative Services and Finance and Audit Committees.

**NOW, THEREFORE BE IT RESOLVED**, by this County Board of McHenry County, Illinois, that it hereby authorizes and directs the Director of Procurement and Special Services to negotiate the final form of the DevNet Property Tax and wEdge Software License, Maintenance and Support Contract for a five-year term with annual costs of \$127,339.00 paid in quarterly installments on or before December 1, March 1, June 1, and September 1; and

**BE IT FURTHER RESOLVED**, that the costs of said five-year contract have been budgeted for and will impact Main Account 432105 – Dept. 90 – Division 9000 – Fund 100 (Non-Departmental – Property Tax Software Support & Maintenance); and

**BE IT FURTHER RESOLVED**, that the County Clerk is hereby authorized to distribute a certified copy of this Resolution to the Director of Information Technology; the Director of Procurement and Special Services; the County Assessor; the County Clerk, the County Treasurer; the County Auditor; the Chief Financial Officer; and the County Administrator.

**Board / Committee Action Requested:**

To approve the Five-Year DevNet Property Tax and wEdge Software License, Maintenance and Support Contract.

**Background and Discussion:**

The County has been successfully utilizing the DevNet Tax Software for eighteen years to collect and distribute property taxes within McHenry County. It is the consensus of the County Assessor, the County Clerk, and the County Treasurer to renew this proposed five-year contract with DevNet for Licensing, Maintenance and Support of the DevNet Property Tax and wEdge Software. The annual cost of this agreement for the next five years will be \$127,339.00. The payments will be made in quarterly installments on or before December 1, March 1, June 1, and September 1. This contract will begin December 1, 2024, and continue through November 30, 2029. Finally, the State's Attorney has reviewed and approved the proposed contract offered by DevNet, Inc., 2254 Oakland Drive, Sycamore, Illinois 60178.
