#### RESOLUTION

SUBJECT: To Adopt the McHenry County Artificial Intelligence Appropriate Use Policy (18)

## **Board / Committee Action Requested:**

To adopt the McHenry County Artificial Appropriate Use Policy.

### **Background and Discussion:**

The Artificial Intelligence Workgroup (Al Workgroup) was developed in September of 2023 after a robust discussion at the monthly Elected Official/Department Head meeting about the advent and implications of the latest artificial intelligence (Al) tools. The Al Workgroup was then developed to learn more about (Al), short-term use cases and best practices.

The following elected offices and departments sent representatives to participate in the Workgroup: Administration, Auditor, Circuit Clerk, County Board, County Clerk/Recorder, ETSB/911, GIS, Health, Information Technology, Planning & Development, Procurement and Special Services, Sheriff, State's Attorney, Treasurer, and Workforce Network Board. In total, the 20 plus member Workgroup has had participation from six of the eight constitutional elected offices and entities under the supervision of four separate boards.

Over many months, the Workgroup researched best practices and different forms of technology that could be leveraged to enhance efficiency and effectiveness of work processes. The Workgroup also learned that the National Association of Counties (NACO), a professional organization representing over 40,000 county elected officials and 3.6 million county employees, was completing its long-term endeavor to develop an AI Toolkit for safe, ethical, and responsible AI usage for counties. The Workgroup implemented NACO's recommendation to complete an AI survey and modified one of its recommended AI policies to better fit McHenry County's needs.

Workgroup members also joined the Gov.Ai coalition, a group comprised of local governments and government professionals who pursue AI best practices.

Workgroup members also met with DuPage County officials to share policy ideas and best practices. Ideas from DuPage County have been incorporated into this policy.

Department heads and elected officials have been updated on the progress of the AI Workgroup regularly for the past year and have reviewed it on October 18, 2024. Department heads and elected officials will also have one more opportunity to review the policy on November 15, 2024, should additional ideas surface or should this committee decide to make any modifications.

The policy was reviewed and approved by the State's Attorney's Office.

The AI Workgroup desires to continue to meet to keep abreast of best practices, recommend policy updates, and discover opportunities to share technology, save taxpayer dollars, create efficiencies, and provide better services.

The AI Workgroup recognizes that this policy will likely need regular updating to keep pace with a rapidly evolving technology. The group commits to bringing policy recommendations to the Administrative Services Committee as necessary.
