WHEREAS, the Supervisor of Assessments and the Chief Deputy reviewed all positions within this department and the reclassification of this position will be supported by the general fund; and

WHEREAS, this requested change does not change the full-time equivalents nor the headcount of the Department; and

WHEREAS, the annualized increase in the base salary from 8E to 9E grade is projected to cost \$3,671; and

WHEREAS, recent and sudden retirements in the Department have reduced the Department's general funds expenditure, negating an increase to the Department's general fund; and

WHEREAS, the mentioned retirements were sudden and after the 2025 Budget was finalized prompting a subsequent review; and

WHEREAS, the implementation of new technology and processes appear imminent due in part to the diligent and steadfast work by the manager; and

WHEREAS, the environment for the change is optimal considering all the above and waiting for the next budget could change the noted dynamics; and

WHEREAS, this reclassification is supported by the County Administrator and the HR Director.

NOW, THEREFORE BE IT RESOLVED, by this County Board of McHenry County, Illinois, that effective immediately, position 05002707 Mapping Section Manager, pay grade 8E, within the Supervisor of Assessments Office will be reclassified to Parcel Maintenance and Mapping Manager, pay grade 9E; and

BE IT FURTHER RESOLVED, that the County Clerk is hereby authorized to distribute a certified copy of this Resolution to Supervisor of Assessments, the Director of Human Resources and the County Administrator.
