

RESOLUTION

Resolution Appropriating Funds for FY2025 Street Sweeping (82)

WHEREAS, the Division of Transportation annually performs curb and gutter street sweeping along County Highways to keep the roadways clear of debris, to ensure that the storm sewer systems function without obstructions, and to comply with the Illinois Environmental Protection Act (IEPA) National Pollutant Discharge Elimination System (NPDES) as street sweeping has a direct benefit on the quality of water; and

WHEREAS, the Village of Cary secured a bid for street sweeping for the 2025 McHenry County Municipal Partnering Initiative (MC-MPI) so multiple agencies within McHenry County can take advantage of the benefits of joint purchasing; and

WHEREAS, this is the first year of a three-year bid which allows for contract renewal annually through the year 2027; and

WHEREAS, bids were opened on March 06, 2025 at the Village of Cary, approved by the McHenry County Director of Procurement and Special Services, and the Transportation Committee has reviewed the bids.

NOW, THEREFORE BE IT RESOLVED, this County Board of McHenry County, Illinois hereby authorizes that the street sweeping contract be awarded, and a PO issued, to Lakeshore Recycling (LRS Holdings LLC) in the amount of eighty thousand dollars (\$80,000.00); and

BE IT FURTHER RESOLVED, that there is hereby appropriated the sum of eighty thousand dollars (\$80,000.00) out of FY2025 budget, from the County Option Motor Fuel Tax Fund; Fund-Dept.-Div.-Main Acct. 262-82-8240-413150 (Highway Maintenance Contracts), for said contract; and

BE IT FURTHER RESOLVED, that this project is hereby designated as Section 25-00000-12-GM; and

BE IT FURTHER RESOLVED, that the Chairman is hereby authorized to execute the necessary contract and contract bond documents for said contract; and

BE IT FURTHER RESOLVED, that the County Clerk is hereby authorized to distribute a certified copy of this Resolution to the County Administrator, the Chief Financial Officer, the Director of Procurement and Special Services and an electronic copy to the Director of Transportation/County Engineer.

RESOLUTION

SUBJECT: Resolution Appropriating Funds for FY2025 Street Sweeping (82)

Board / Committee Action Requested: For consideration is a resolution approving bids and appropriating funds for FY2025 street sweeping services.

Background and Discussion: The McHenry County Division of Transportation (MCDOT) annually sweeps approximately 744 miles of County Highways and bridge structures. This entails making 6 or more rounds of sweeping curb & gutter and drainage structures throughout the County's transportation system.

Using a contractor saves on the cost of maintenance and repairs, fuel, equipment and allows MCDOT maintenance workers to address other operational needs. MCDOT staff will provide oversight to the contractor ensuring the work is performed as specified per the bid.

This is an annually budgeted item and bids were opened on March 06, 2025, by the Village of Cary as part of the McHenry County Municipal Partnering Initiative (MC-MPI) so that other agencies within McHenry County can take advantage of the benefits of joint purchasing. This is the third year of a 3-year bid for FY2025, FY2026 & FY2027.

Only one bid was received. Lakeshore Recycling was the low bidder for a sweeping unit cost of \$15,187.50 per round.
