

# RESOLUTION

## Resolution Awarding 2025 Construction Contracts on Behalf of Road Districts (82)

**WHEREAS**, the Illinois Highway Code requires that the County Board accept bids and award contracts that utilize Road District Motor Fuel Tax Funds for maintenance and construction; and

**WHEREAS**, contract maintenance resurfacing bids for Alden, Burton, Coral, Dorr, Dunham, Grafton, Greenwood, Hartland, Hebron, Marengo, Richmond, Riley and Seneca Township Road Districts were opened March 5, 2025 at the Division of Transportation and the Transportation Committee has reviewed the bids; and

**NOW, THEREFORE BE IT RESOLVED**, by this County Board of McHenry County, Illinois, that Township Road District maintenance resurfacing contracts be awarded as follows:

SUBJECT: Resolution Awarding 2025 Construction Contracts on Behalf of Road Districts

**Board / Committee Action Requested:**

For consideration is a resolution accepting Road District resurfacing bids for various Townships in 2025.

**Background and Discussion:**

Each year, the McHenry County Division of Transportation assists most of the townships with bidding for roadway paving. The paving to be completed is funded 100% by the townships. The MCDOT facilitates the bid and, when requested, administers the contracts.

A public bid opening was held on March 5, 2025 at the Division of Transportation. All were checked for errors and the bids were tabulated for each project.

This is an annual bid, and the projects are funded through Township Motor Fuel Tax Funds and other Township funds as assigned by the respective Road Commissioner. Algonquin, McHenry and Nunda Townships typically utilize their MFT funds on Private Road Maintenance and the purchase of salt, paint & beads and HMA materials. Chemung Township will not be conducting a resurfacing program in 2025.

Coral Township had an alternate bid, which was accepted. The alternate bid has no bearing towards the low bidder as the low bid is based off the base bid only.

**Impact on Human Resources:** McHenry County Division of Transportation engineering staff will provide construction administration, engineering, and inspection services to assist the Township Road Commissioners with these contracts. The cost for this service is provided to the Townships, by the County, at 5% of the cost of construction. This amount is a savings over the costs that could be expected by a private engineering firm providing the same construction administration, engineering, and inspection services
