## Resolution Appropriating Funds for FY2025 Finish Mowing (82)

**WHEREAS**, the Division of Transportation annually performs rights-of-way finish mowing along County Highways in the urbanized areas of the County and the landscaped medians; and

WHEREAS, the McHenry County Procurement and Special Services Department secured a bid for finish mowing through the McHenry County Municipal Partnering Initiative (MC-MPI); and

**WHEREAS**, bids were opened on February 20, 2025, at the Procurement and Special Services Department, approved by the McHenry County Director of Procurement and reviewed by the Transportation Committee.

**NOW, THEREFORE BE IT RESOLVED,** this County Board of McHenry County, Illinois hereby authorizes that the finish mowing contract be awarded, and a PO issued, to Langton Group of Woodstock, IL in the amount of \$37,305.74; and

**BE IT FURTHER RESOLVED**, that there is hereby appropriated the sum of thirty-seven thousand, three hundred five dollars and seventy-four cents (\$37,305.74) from the FY2025 County Option Motor Fuel Tax Fund; Fund-Dept.-Div.-Main Acct. 262-82-8242-413150 (Highway Maintenance Contracts), for said contract so that the Division of Transportation can have the right-of-way finish mowing on County Highways contracted, associated documents are attached herein; and

**BE IT FURTHER RESOLVED**, that this project is hereby designated as Section 25-00000-13-GM; and

**BE IT FURTHER RESOLVED,** that the Chairman is hereby authorized to execute the necessary contract and contract bond documents for said contract; and

**BE IT FURTHER RESOLVED**, that the County Clerk is hereby requested to distribute a certified copy of this resolution to the Chief Financial Officer, the County Auditor, the Director of Procurement and Special Services and an electronic copy to the Director of Transportation/County Engineer.

#### RESOLUTION

SUBJECT: Resolution Appropriating Funds for FY2025 Finish Mowing (82)

#### **Board / Committee Action Requested:**

To approve the resolution approving bids and appropriating funds for FY2025 right-of-way finish mowing.

**Background and Discussion:** The McHenry County Division of Transportation (MCDOT) annually finish mows a total of approximately 46 miles per rotation on County Highways. Finish mowing is performed 26 weeks throughout the season primarily along the roadways in the more urbanized area of the County and the landscaped medians.

For many years, the MCDOT has used its own staff and equipment to perform finish mowing on County Highways. Using a contractor will save on the cost of maintenance and repairs, fuel, equipment and allow maintenance workers to address other operational needs. MCDOT staff will provide oversight to the contractor ensuring the work is performed as specified by the bid.

This resolution is for approximately 6 miles of finish mowing services along Randall Road, Rakow Road, Ackman Road, Algonquin Road, and River/Dowell Road roundabout located within the southeast part of the County.

Bids were opened on February 20, 2025, by the McHenry County Procurement and Special Services Department as part of the McHenry County Municipal Partnering Initiative (MC-MPI) so that other agencies within McHenry County can take advantage of the benefits of joint purchasing. The bid award is for the lowest responsive and responsible bidder that is the most advantageous and in the best interest of the County and other Local Government Units.

With FY2025 budgeted funds, MCDOT will utilize Langton Group for 26 weeks totaling \$37,305.74. This is the first year of a four year of the contract. The Director of Procurement and Special Services and the Director of Transportation/County Engineer agree to award this contract to the lowest responsive, responsible vendor Langton Group, of Woodstock, IL.

Impact on Human Resources: None.

Impact on Budget (Revenue; Expenses, Fringe Benefits): The requested appropriation amount for landscape finish mowing is \$37,305.74 from the County Option Motor Fuel Tax Fund; Fund-Dept-Div-Main Acct. 262-82-8242-413150 (Maintenance Agreements). This appropriation amount is within the FY2025 budgeted amount.
