SUBJECT: Resolution Awarding 2025 Materials Bids on Behalf of Road Districts (82)

Board / Committee Action Requested:

Accepting Road District material bids for various Townships.

Background and Discussion:

Each year, the Division of Transportation (DOT) assists some of the townships with bidding for roadway materials, typically asphalt. The materials to be purchased are funded 100% by the townships. The DOT facilitates the bid and when requested, administers the contracts.

A public bid opening was held on March 5, 2025 at the Division of Transportation. All were checked for errors, mileage costs were calculated for the materials bids, and the bids were tabulated for each project.

This is an annual bid and the projects are funded through Township Road District funds as assigned by the Highway Commissioners.

Impact on Human Resources:

McHenry County Division of Transportation engineering staff provided contract administration up to the bid opening. The maintenance materials proposal drafting and contract administration requires minimal time from engineering staff, as the documentation is standardized and can easily be furnished alongside the Township Resurfacing contracts.
