  - a. The Parties will participate in the MAPP Core Team, a steering committee for the CHA.
  - b. Decisions related to the scope, methodology, and dissemination of the CHA results will be made by members of the MAPP Core Team.
- 3. This MOU shall become effective upon the date of signature and remain in effect until the completion of the CHA.
