Outreach and Training Updates:

- As of March 11th, we have trained 734 individuals in QPR this year.
- The 988 advertising campaign has been launched. The March article on reducing stigma will be published during the second week of the month.
- SOSA (Survivors of Suicide Attempt) support group started on March 4th with 3 active participants.
 - There is already enough interest to offer a future session.
- 224 gun locks have been handed out to community members and organizations for pick up at local centers.
- 8 gun lock pick up centers have been established in the county.
- Partnership has been established with 1 gun shop.
- As of March 13th, we have educated 41 individuals regarding firearm safe storage and firearm restraining orders.
