**WHEREAS,** the Problem Solving Courts of the 22<sup>nd</sup> Judicial Circuit of McHenry County operate the Drug Court, Mental Health Court, and DUI Court Programs of McHenry County which rely upon experts in the field of mental illness and substance abuse treatment; and

**WHEREAS**, these programs operate with fidelity to the established evidence based practices and ten key components for problem solving courts; and

**WHEREAS**, the Problem Solving Court programs have been found to be a viable alternate to incarceration; and

**WHEREAS**, the DUI Court program has grown in size and now necessitates a second treatment clinical position; and

**WHEREAS**, the McHenry County Board pursuant to Resolution # R-202407-42-154 authorized the acceptance of said grant including position creation; and

**WHEREAS**, the revenue portion of the FY2025 was established during the budget process, which created a fund balance enhancement; and

WHEREAS, it is now necessary to establish the expenditure budget for FY2025; and

**WHEREAS**, a budget line item transfer is required in the amount of \$111,059 to the Court Administration 2025 budget.

**NOW, THEREFORE BE IT RESOLVED,** by this County Board of McHenry County, Illinois, that it hereby authorizes a budget line item transfer to the following budget lines for the proper accounting of said grant award in Court Administration FY25 budget:

#### **Board / Committee Action Requested:**

Approve a resolution establishing an expense budget for grant award from the Illinois Department of Transportation in the amount of \$111,059.13 and a budget line item transfer in the Court Administration 2025 budget.

#### **Background and Discussion:**

Due to the demand for services, it is necessary to expand the roster of the Office of Special Projects to meet the need. The 22<sup>nd</sup> Judicial Circuit sought and was awarded grant funding in the amount of \$111,059.13 from the Illinois Department of Transportation which will cover the costs of a clinician as well as other ancillary costs.
