## Resolution Approving Entering into an Intergovernmental Agreement between McHenry County and the City of Woodstock for GIS Services (65)

**WHEREAS**, the City of Woodstock requested GIS services from McHenry County; and

**WHEREAS**, the County and the City are authorized by the terms and provision of the Intergovernmental Cooperation Act, 5 ILCS 220/01 et al., to enter into intergovernmental agreements, ventures, and undertakings to perform jointly any governmental purpose or undertaking either of them could do singularly; and

**WHEREAS**, a fee of \$75 per labor hour will be paid by the City to the County for GIS services to the GIS Enterprise Fund; and

**WHEREAS**, the term of this agreement shall be for one year and shall automatically renew for subsequent one-year terms unless otherwise stated; and

**NOW, THEREFORE BE IT RESOLVED**, by this County Board of McHenry County, Illinois, that it hereby authorizes the County Board Chair to enter into an intergovernmental agreement between the County and the City of Woodstock for GIS services; and

**BE IT FURTHER RESOLVED**, all fees paid by the City of Woodstock to the County for GIS services will be deposited to the GIS Enterprise Fund under revenue budget line 094701-94-65-6500-234; and

**BE IT FURTHER RESOLVED**, that the County Clerk is hereby authorized to distribute a certified copy of this Resolution to Director of GIS, Chief Financial Officer, and the County Administrator.

**SUBJECT:** Resolution Approving Entering into an Intergovernmental Agreement between McHenry County and the City of Woodstock for GIS Services (65)

**Board / Committee Action Requested:**

Authorize County Board Chairman to enter into an intergovernmental agreement with City of Woodstock for GIS services.

**Background and Discussion:**

The City of Woodstock requested the McHenry County GIS Department provide support GIS services to eliminate redundancy and provide greater efficiency for both government agencies. This intergovernmental agreement is to assist with providing the City various GIS services such as GIS database development, maintenance, and administration. Additionally, GIS staff will provide support as needed or requested by the City with GIS analysis, application development, data capture, and GIS drone data capture. This agreement is for one year and shall automatically renew for subsequent one-year terms unless otherwise stated.

**Impact on Human Resources:** None

**Impact on Budget (Revenue; Expenses, Fringe Benefits):** The City of Woodstock will pay a fee of \$75 per labor hour for time spent on GIS services to the County. The GIS fees will be deposited into the McHenry County GIS Enterprise Fund under revenue line 094701-94-65-6500-234.

**Impact on Other County Departments or Outside Agencies:** Providing GIS services to the City of Woodstock will eliminate redundancy between agencies and provide greater efficiency.
