

## RESOLUTION

### **Resolution Authorizing Four (4) Years of a Contract with Aadvanced Business Solutions Software, LLC (ABS) of Lakeside California for a Subscription Based Electronic Health Record System (51)**

**WHEREAS**, the Department of Health provides a wide range of services to the citizens of McHenry County; and

**WHEREAS**, the Department has been utilizing a proprietary software since 2018 to enhance its operational capabilities and maximize efficiencies and effectiveness of data collection, assessment and reporting of information; and

**WHEREAS**, the ABS system is used to maintain records electronically including patient information, visits, exams, immunizations and other medical data; as well as to access permits, application and inspection records, record inspection results and to create inspection reports in the field; and

**WHEREAS**, the Board of Health, Public Health Administrator, and the Director of Purchasing entered into a one (1) year base contract (12/01/2025 through 11/30/2026) with Advanced Business Software, LLC of Lakeside, CA, and authorized an additional three (3) year option (12/1/2026 through 11/30/2029), based upon the Department's satisfaction with the vendor and availability of funds; and

**WHEREAS**, there are sufficient funds in the Department's FY2026 budget to cover the expense of the subscription-based proprietary information management systems for a total annual cost of \$70,000; and

**WHEREAS**, the Department is satisfied with the vendor's product and services, and is requesting a one-year contract with three (3) option years to continue using the proprietary information management system software through 11/30/2029.

**NOW, THEREFORE BE IT RESOLVED**, by this County Board of McHenry County, Illinois that the Director of Purchasing is authorized to execute a one-year contract with Advanced Business Software, LLC of Lakeside, CA, with three (3) option years to continue a subscription based, electronic information management system in FY2026 through FY2029, for a total annual cost not to exceed \$70,000 each year; and

**BE IT FURTHER RESOLVED**, by this County Board of McHenry County, Illinois that \$70,000 of said annual costs will be covered by funds under existing budgeted line items Main Acct 432100-40-51-5110, Main Acct 432100-40-51-5111, Main Acct 432100-40-51-5125, and Main Acct 432100-40-52-5200, Main Acct 432100-40-51-5115; and

**BE IT FURTHER RESOLVED**, that the County Clerk is hereby authorized to distribute a certified copy of this Resolution to the Public Health Administrator, the Assistant County Administrator, the Chief Financial Officer, the County Auditor, and the County Administrator.
