

# RESOLUTION

## Resolution Authorizing the McHenry County Sheriff to Purchase a G2 Imaging Laser Scanner from Hexagon US Federal for \$51,000 (32)

**WHEREAS**, it is the responsibility of the Sheriff's Office to secure a crime scene/traffic crash and preserve the evidence surrounding such event; and

**WHEREAS**, the Sheriff requested a 3D laser scanner during the FY26 budget process to be used by the McHenry County Criminal Investigations Division and McHenry County Accident Investigations Unit to take 3-dimensional photographs of a crime scene/traffic crash for more accurate investigation and prosecution, and

**WHEREAS**, this supplemental request was approved and included in the Sheriff's FY26 budget as a capital purchase in the Investigations Division and is on the GSA contract (47QTCA18D003G), so a bid was not completed.

**NOW, THEREFORE BE IT RESOLVED**, by this County Board of McHenry County, Illinois, that it hereby authorizes the purchase of a G2 Imaging Laser Scanner from Hexagon US Federal, Huntsville AL, for the Sheriff's Office for \$51,000; and

**BE IT FURTHER RESOLVED**, the funds for this purchase were approved in the Sheriff's Office FY26 budget in budget line item 100-32-3245-601000 (Office Equipment -Capital Outlay) for \$48,700 and in fund 350-32-3200-509900 (Miscellaneous Commodities) for \$2,300; and

**BE IT FURTHER RESOLVED**, that the County Clerk is hereby authorized to distribute a certified copy of this Resolution to the Sheriff, Auditor, Chief Financial Officer and County Administrator.

**SUBJECT:** Resolution Authorizing the McHenry County Sheriff to Purchase a G2 Imaging Laser Scanner from Hexagon US Federal for \$51,000 (32)

**Board / Committee Action Requested:**

Authorization for the purchase of a 3D scanner for the Sheriff's Office.

**Background and Discussion:** This purchase was a supplemental request in FY26 budget and approved for the amount quoted in 2025. This 3d scanner will be used for crime scenes and traffic accidents and will allow investigators and prosecutors to analyze the scene three-dimensionally. This will provide more accurate and immediate measurements and will eliminate human error and hours of work (overtime) for investigators who are measuring by hand.

**Impact on Human Resources:** None

**Impact on Budget (Revenue; Expenses, Fringe Benefits):**

This item was budgeted and approved in the Sheriff's FY26 budget in 100-32-3245-601000 for \$48,700 and in 350-32-3200-509900 for \$2,300. The original quote in 2/2025 for budget was \$48,700 but that quote expired and the new quote is \$50,998.25 so the remainder will come out of our DUI Conviction funds.
