## Resolution Authorizing the Acceptance of the Illinois Court Technology Modernization Program Grant from the Administration Office of Illinois Courts for FY26 and an Emergency Appropriation to the Court Administration FY26 Budget (42)

**WHEREAS**, the 22nd Judicial Circuit of McHenry County has been recognized by the Administrative Office of Illinois Courts for its effective work in implementing new technology to modernize the courthouse; and

**WHEREAS**, the Administrative Office of Illinois Courts has awarded the 22nd Judicial Circuit of McHenry County an Illinois Court Technology Modernization Program Grant award in the amount of \$50,000.00 which will allow the 22nd Judicial Circuit to purchase and utilize new technology throughout the courthouse to modernize and streamline processes for employees and the public; and

**WHEREAS**, the Illinois Court Technology Modernization Program grant award requires no local match by the County, but does require an emergency appropriation to Court Administration's fiscal year 2026 budget to allow for the proper recording of grant revenue and expenditures; and

**WHEREAS**, the Trial Court Administrator and the Chief Circuit Judge of the 22nd Circuit is recommending approval by the County Board to accept the grant award and establish a budget to account for the \$50,000.00 of the award through an emergency appropriation to the FY26 budget to the line items below:

**Background and Discussion:**
