Authorizing an Amendment to the Community Development Senior Service Grant 2026 Agreements and New Award to the Woodstock Food Pantry (10)

WHEREAS, the County Board approved contracts with non-profit organizations and projects under Resolution number R-202510-10-208 effective December 1, 2025; and

WHEREAS, the Planning and Development department and County Treasurer Donna M. Kurtz successfully gained additional funds through investments; and

WHEREAS, during the March 11, 2026, meeting, the Senior Service Grant Commission made a recommendation to provide additional funding to the projects listed below; and

WHEREAS, on March 11, 2026, the Senior Service Grant Commission made a recommendation to fund The Woodstock Food pantry in the amount of \$29,412.80.

NOW, THEREFORE BE IT RESOLVED, by this County Board of McHenry County, Illinois, that it hereby authorizes the County Board Chairman to enter into amendments with the contract agreements approved on the Resolution number R-202510-10-208 to add the amounts listed below and to enter into a new contract with the Woodstock Food Pantry.

PROJECTS:

- **Independence Health & Therapy – Adult Day Health** - \$300,000.00 to receive an additional \$19,000.00.
- **Independence Health & Therapy – Memory Care** - \$335,000.00 to receive an additional \$16,195.00.
- **Home of The Sparrow – Supportive Services for Seniors Facing Homelessness & Housing Insecurity** - \$45,000.00 to receive an additional \$ 10,000.00.
- **Pioneer Center for Human Services – Senior Residential Program** –\$150,000.00 to receive an additional \$12,211.00.
- **Pioneer Center for Human Services – SOAR** - \$105,000.00 to receive an additional \$12,006.80.
- **Harvard Community Senior Center – Core Services** - \$30,000.00 to receive an additional \$40,000.00.
- **Woodstock Food Pantry-Increased Food Pantry Services to Seniors** received \$0.00 to receive \$29,412.80.

BE IT FURTHER RESOLVED, that the County Clerk is hereby authorized to distribute a certified copy of this Resolution to the Director of Planning & Development; the Community Development Administrator; the County Auditor, the County Treasurer, the Chief Financial Officer, and the County Administrator.
